PRIVACY STATEMENT FOR CUSTOMERS

We are willing to inform that the legislation on privacy (Legislative Decree 196/03, EU Regulation 2016/679, Legislative Decree 101/18) provides for the protection of individuals with regard to the processing of personal data. The latter will be based on principles of correctness, lawfulness, transparency, protection of the privacy of those concerned.

Schunk Carbon Technology S.r.l., with headquarter in Magenta, Via Romolo Murri 22/28, in its capacity as Data Controller, collects and processes Customer data for the following purposes:

- 1) to fulfill obligations provided for by law and/or EU regulations;
- 2) to manage and execute purchase orders;
- 3) to perform obligations arising from any contract between the parties;
- 4) to manage and control commercial risks, prevent possible insolvencies or defaults;
- 5) to respond to any requests for information.

The conferment of data is functional and necessary for the supply by the Owner of the relevant products/services, for the opening and management of contracts, and necessary to meet any requests of the interested party (technical, commercial information, etc.).

Any refusal to provide such data may result in the failure or partial execution of the contract, and the continuation of the relationship.

The data will be processed both with manual tools and with the use of dedicated software.

Schunk Carbon Technology S.r.l. will only be able to communicate your data:

- to subjects who provide functional services for the above mentioned purposes;
- to subjects who process data in execution of specific legal obligations.

The complete and detailed list of these subjects, who act as Data Processors, is available at the headquarter of the Data Controller.

The data are also processed by the staff of Schunk Carbon Technology S.r.l. by virtue of specific instructions provided regarding the purposes and methods of processing.

No data transfer outside the European Union Territory is foreseen.

The personal data of each Customer will be kept for the entire duration of the contractual relationship plus any period of historical storage required by law.

According to art. 15 and following of the EU Regulation 679/2016 the Customer has the right to know, at any time, which data are in our possession and how they are used. The Customer also has the right to have them updated, integrated, corrected or deleted, to ask for them to be blocked and to object in whole or in part to their processing, even in relation to only one of the purposes or methods listed above, by writing to the following address info@schunkitalia.it.

Should the data subject find a violation of his/her rights, he/she may apply to the competent supervisory authority pursuant to art. 77 of EU Regulation no. 679/2016; without prejudice to the possibility to apply directly to the judicial authority.
